

Kingdom Covenant and Deed of Trade GUIDE & Template

(The actual template to fill out is at the end of this guide.)

The **Kingdom Covenant of Trade** is your legal partnership agreement with Heaven.

Use this template as you work with Father, Jesus or Holy Spirit, etc. in the Business Complex in heaven. This Kingdom Covenant **establishes your business** in Father's Kingdom. It also **commissions you**, elevating you from being a Christian doing business to an authorized **Kingdom Operative** taking territory from the enemy and ceding it to the Kingdom of Yahweh.

It presents evidence that you have the right to operate this business according to Kingdom principles. It assumes you've already received your Destiny Scroll from Father and have written out the Vision you are co-creating with the Lord. It also assumes you have your **Mantle**—your God-given anointing to be a business owner, and your **Mandate**—your God-given authority to carry out this charge.

The **Deed of Trade** is the 2nd part of this document and establishes your mountain—or position of governing, your trading floor and the trade routes that interface with Yahweh's realm of miracles and resources to fund and operate your Kingdom business.

Once you have filled out the necessary information, you then submit it to the Court of Titles and Deeds in the court of Business & Finance for approval. They may have you edit or add something, or they may direct you to the healing rooms if you have woundings that require healing before you can engage in doing business in heaven.

When you get approval, ask the scribes to make copies and deliver them as appropriate. They will know who needs a copy, and where to send them. Be sure to post your copy in your office in the spirit realm, **and in the 3D world**, with the date it was approved. Your job is then be to hold it inside your realm (heart), nurturing, protecting, and ministering to it as you birth it into the earth. It's important to declare it aloud in gratitude for the completed work (the fully realized vision) to manifest. Expect it to grow and evolve as you and your business grow and evolve.

Feel free to add or edit, or rearrange, or whatever you feel is appropriate. If you get stuck, just keep asking questions and write whatever comes to you as if you DO know the answer.

II. Legal Heavenly Identification (How Heaven sees your Business Identity)

II. Establish Your Boundaries to Stake Your Claim on that Territory

This puts stakes in the ground and draws the boundary lines in multiple realms. Strong, clear boundaries are very important to the Lord, and are seen throughout the bible.

1. Present your WHY & PASSION evidence of your right to do this business: Why are you doing this business? (What are you so passionate about that you would go through the challenge of starting and growing a business? – Usually it has to do with what you've overcome in your life that you want to help others avoid or overcome.) Prophetic words and revelations may also be presented as evidence here.
2. What problem(s) does your business solve? (This is not asking what solution you bring. Describe what issue(s) your client is experiencing.)
3. How do you solve it/them – by what method(s)?
(What you trade, and how you trade, including your business model)
4. Who do you serve? (What demographics, psychographics, and in what industry. Identify and stake your claim on these people.)

5. Where do you trade? (Physically, Online, in the Airwaves, Spiritually, etc.) This stakes your territory, so claim all the platform pieces you need: Domain, website, social media profiles, choice ad placement where your ideal client will see it, choice sign locations, and so on.
6. What Intellectual Property territory have you already staked, or plan to stake by trademark, copyright, or patent? (Business name, logo, slogan, proprietary processes, website, educational or creative works, inventions, and so on.) This is very important to protect the God ideas he's given you.

III. Establish Your Kingship Authority Under Father's Ownership

1. Formally place your business under Father's authority as Owner and CEO (King of Kings), and declare your position as earthly Owner, spiritual Steward/King.
 - a. If you've never seen yourself as a King, I recommend doing the King Up! Activation on the SCB website, or if you're doing the course, it's module 5, lesson 1.
 - b. You may also want to take a look at and engage with your throne at this point, if that's something you're aware of. (ignore if not - or go get my teaching.)
 - c. The other side of properly positioning yourself as a King and CEO is to release the employee and victim needing to be rescued mindsets.
3. Make your declaration of your roles and responsibilities as the authorized head (King and Priest) of every aspect of the business in the earthly and spiritual realms. (Ref. 1 Sam 10:25) Don't forget about indirect roles and responsibilities such as leader, role model, protector, influencer, and so on.

IV. Establish Your Rules of Conduct and Partnership with Heaven

1. PRINCIPLES: Make a declaration of agreement to operate according to Kingdom Principles, which are universal, there's a cause and effect regardless of your awareness or "belief" in them.

Here are some suggestions:

- Law of Sowing and Reaping: We acknowledge that every word, act, and investment produces harvest after its kind. (*Gal. 6:7-8*)
- Law of Reciprocity: We affirm that the measure we use toward others will be measured back to us. (*Luke 6:38*)
- Law of Just Weights and Scales: We commit to absolute fairness and transparency in all trade, pricing, and agreements. (*Prov. 11:1; Lev. 19:35-36*)
- Law of Honor: We will cultivate a culture of honor toward God, authority, clients, employees, and partners. (*Ex. 20:12; 1 Sam. 2:30*)
- Law of Humility and Exaltation: We acknowledge that humility attracts grace, while pride brings downfall. (*Prov. 16:18; James 4:6*)
- Law of Faith (Expectancy and Intention): We operate by faith, not sight, calling forth unseen resources into manifestation. (*Matt. 9:29; Heb. 11:1-3*)
- Law of Love: We affirm that love fulfills the law, and all business will be conducted in love. (*1 Cor. 13:8; Rom. 13:10*) We also choose to operate love-based, rather than fear-based in decision-making, negotiating, conflict resolution, relationships and all other areas. (*1 John 4:18*)
- Law of Agreement (Unity): We affirm the multiplying power of unity and alignment in vision, speech, and purpose. (*Matt. 18:19; Gen. 11:6*)
- Law of Stewardship and Multiplication: We will faithfully steward what is entrusted to us, knowing wise stewardship produces multiplication. (*Matt. 25:14-30*)
- Law of Mercy and Judgment (operating according to the law, morality, administering appropriate punishment and rewards): We affirm mercy as a governing principle, knowing the merciful receive mercy. (*Matt. 5:7; James 2:13*)

- Law of Increase (Fruitfulness and Multiplication): We align with the creation mandate of fruitfulness and multiplication. (*Gen. 1:28; 2 Cor. 9:10*)
- Law of the Spirit of Life: We choose life-giving practices, rejecting corruption and the law of sin and death. (*Rom. 8:2*)
- Law of Tithing & Firstfruits: We consecrate the first and best of all increase to YHWH, that the whole may be blessed. (*Mal 3:10, Prov. 3:9; Ex. 23:19*)
- Law of Boundaries (Knowing and staying in Your Metron or sphere of influence – your kingdom: (*1 Cor 7:17, Prov 4:25-26, 2 Cor 10:13*)

2. What values will your business espouse? Values serve as the criteria or standard that guides our choices, behaviors, and evaluation of people, ideas, and things. It is critical to the health of your business that these values are exemplified in the day-to-day operations, and in the experience of your team and clients.

3. What culture will you establish and maintain? "Culture" refers to the practices, procedures, and behavioral norms experienced by insiders and seen by outsiders in a business. It is influenced by values, attitudes and goals, so you want to make sure everyone is on the same page.

4. What will you NOT tolerate? (self explanatory - line in the sand)

5. Who do you work with? What qualities and characteristics does your team have? Call in - declare - exactly who you want to play in the sandbox with, both Heavenly and Earthly roles.

6. Partnership: Formally agree to receive counsel and assistance, including correction and pruning, from Heaven regarding operations, strategies, daily tasks, personnel, assets of any kind, and all other areas known or unknown.

V. Finalize and Seal this Declaration of Trade

Make it official! Submit it to heaven for approval, and then make copies and distribute.

PART 2: Deed of Trade

This establishes your trading floor, the foundation from which you build your business, which exists in the spirit realm, and overlays your mountain. Think of it the same way you would in the 3D world – this is your real estate, your headquarters, your warehouse(s), your distribution center(s), your retail storefront(s), and so on. It also establishes your trade routes, which are very important to protect and maintain.

Remember that you are now operating a Spirit-Centered™ business, and therefore building it as an heir to Father's Kingdom. There is both a limitless aspect to what you can build, and a process journey to manifest it into the 3D world by the power of your faith (intention and commitment to action) and agreement.

Setting up Your Trading Floor

1. **Declaration of Receipt:** Acknowledge (declare) that Father, as owner, has now deeded the territory over to you and established you as King - the authorized steward and possessor. Receive it and seal the conveyance of this transfer across timelines and dimensions and declare it has a clear title.
2. **Property Description:** If you're just starting a business, simply declare that you take possession of the dimensional realms and territory assigned to your business. If you've gone into the Business Complex of heaven to see your office suite there, describe it here.

If you already have an established business, describe both the spiritual and temporal territory you are now officially declaring as yours. Include future real estate/expansions as well. Remember, this is your IDEAL – your declaration of what you desire to see manifest. You may describe it in phases, if that helps get from where you are to where you want to be.

3. **Declaration of Rights:** (You may have more...)
 - Right of Control – You may use the territory as you see fit.
 - Right of Exclusion – You get to say who comes and goes.

- Right of Enjoyment – Feel free to set up extravagant atriums, conference centers, lounges, breakrooms and entertainment for your associates and assistants. Whatever makes you happy!
- Right of Expansion – Acknowledge the possibility that you haven't been shown the fullness of what your business might be yet.
- Right of Disposition – You may transfer ownership if you choose.

4. **Finalize and Seal this Deed of Commerce and Trade:**

I seal and protect this deed and the territory it represents by Heaven-assigned sentries and other beings as needed. across all timelines, ages, realms and dimensions to eternity past and infinity future.

IV. Establish Your Kingship Authority Under Father's Ownership

Furthermore, I declare **(biz name)** as my God-given kingdom. Let it be known that I and my business are now in covenant partnership with Heaven and Father's Kingdom. The finished work of Jesus Christ upholds this covenant.*

I seal and protect this declaration across all timelines, ages, realms and dimensions to eternity past and infinity future. No deterioration of its potency shall be permitted by forgetfulness, neglect or abandonment. I furthermore declare it to be a living document, breathing life, direction and stability into my businesses as I engage with it.

And finally I DECLARE that with this covenant agreement, I am no longer a Christian doing business. I am now a Kingdom Operative taking territory from the enemy and ceding it to Yahweh's Kingdom. I am here to shift atmospheres, dismantle evil systems, and restructure culture to bring Ya's will into the earth, and all of Heaven is now backing me! In the mighty name of Yeshua, Amen.

2. APPROVAL: Watch what the approval looks like. (Stamped, sealed, celebration, etc.)

3. SUBMISSION:

I ask for copies to be made and distributed to everyone who needs to review them. Furthermore, I request a copy to be sent to the kingdom of darkness to officially put them on notice that this covenant has been made, and any usurpation will be met with the full forces of heaven's armies. For Jehovah Sabaoth, the Lord of Angel Armies Himself says, "Touch not my anointed ones, and do my prophets no harm!"
